This change order rebalances quantities for items actually installed or utilized in multiple accounts through construction in 2025. Primary additive items included water valve adjustments and a storm sewer structure repair that were not anticipated when the project was bid. Largest additional item was for a temporary traffic signal, which allowed for two-way traffic, in particular bus service, to remain on Badger Rd. during construction, while there was only adequate width for a single lane.

This resolution establishes the 2026 rates for the sanitary sewer utility, stormwater utility, and landfill fee, and also makes adjustments to the 2026 operating budgets to reflect these changes. For the average residential customer, the proposed rates reflect an approximately 2.7% increase for the sewer utility (approx. \$1.06/mo), 2.3% increase for stormwater (approx. \$0.29/mo), and no increase for the landfill fee. The primary driver of the increase for the sanitary sewer utility rates are increases in treatment charges from Madison Metropolitan Sewerage District, and debt service on capital projects for the stormwater utility.
